  - Is still working with the State to find agreed methodology:
    - Monitor air surrounding school prior to start of project to establish "baseline" asbestos readings
    - State is wanting to encapsulate the building with spray on liner (adds unnecessary cost)
    - If any issues during debris transport, will require "major spill" report and work stopped for investigation
  - o If Roche has not received approval from State by the March Board meeting, may need to figure out backup plan.

- Finalizing designs for final projects to go to bid.
- Construction Considerations
  - o Locker room Roche is working on getting a few more details to narrow down price tag.
  - Elementary drainage ditch estimated at \$65K that includes storm piping, grading, etc
  - o Elementary secure entry will be presented to financial committee
- Committee Updates

    - Seeking Precision's help with the Mission & Vision and the governance structure of the school
  - o Calendar
    - Meeting February 7 to get proposals together for March faculty council
  - Budget
    - Meeting scheduled to start discussing 20/21 budget
