Action Items

- Consent Agenda approved. Motion by Woods, seconded by Armendariz, unanimous vote. Consent agenda included:

 - Approval of Teryl Wessels' resignation.

Discussion Items

- Construction
 - No update.
- Enrollment
 - Retention from '18/19 year is 87%. Currently have 10 students over budgeted amount (866 with a budget of 856), 28 offered positions, and 65 on the waitlist
- Summer facilities update
 - Gym updates have been completed. Will be replacing stair treads at Prep with no-slip treads.
- Personnel update
 - SPED position at UCES has been filled with temporary staff with hopes of becoming permanent. UCPS has hired a third-party custodian company to fill janitorial needs.
- Assessments

OUCES has growth outperforming the state in CMAS Growth Report. District 6 Superintendent Pilch praised UCES for its performance. UCPS high school grade levels are performing at or above state levels. Middle school has relatively poor performance and is planning on using the CMAS information to help identify stagnant practices and implement change. Some concerns were raised about the fact that the elementary performance was increasing but middle school was decreasing. Why can't UCS maintain the level of performance from 5th to 6th grade when retention is 85%+ (suggesting the same students are taking the tests but doing worse)? Mr Fowler informed the board that they are implementing more classroom walkthroughs for observation and objective feedback to try to plan corrective actions.
